The University embraces the vision outlined in the National Education Policy (NEP) with CBCS, aimed at providing high-quality	

education for holistic development of students. Faculty members engaged in discussions to understand and implement key principles of the NEP, such as diversification of curricula and pedagogy, integration of technological innovations, and fostering critical thinking, creativity and logical decision making skills. Since the academic year 2021-2022, the University has effectively implemented the NEP-2020, for both UG and PG aligning with NEP Regulations, 2021. Institutional NEP policies were proposed, approved and integrated into the Statutory Academic Council and the Governing Body of State Government. Academic programs have been revamped to include Multidisciplinary/Interdisciplinary courses as electives, providing students with enhanced flexibility in their course selection. Additionally, students have the opportunity to choose open elective courses from other departments, promoting cross[1]disciplinary learning and holistic development. The curriculum structure now includes various components such as Discipline Specific Core Courses, Electives, Ability Enhancement Courses, Skill Enhancement Courses, Value-Based Courses, Yoga, Health & Wellness, Sports and Physical Fitness. Through these proactive measures, the university demonstrates its commitment to implementing the recommendations outlined in the NEP, thereby enriching the educational experience and nurturing well-rounded individuals equipped for success in a rapidly evolving global landscape. NEP also focuses on human values, ethics and service to the society. It has introduced various subjects such as India and Indian Constitution, Environmental Science, Gender Equity, Financial Awareness, Digital Fluency, Artificial Intelligence, Cyber Security as skill enhancement courses(SEC) at degree level for the students of all discipline. Extension activities, coordinated by various units such as NSS, NCC, Scouts, YRC, Red Ribbon club, and other cells of the college, play a pivotal role in raising students' awareness about their health, community and environmental values. These extension activities impart sense of social responsibility among students. Collaborative endeavors undertaken within the institution provide students with opportunities to broaden their perspectives and adapt to different learning environments. By participating in such activities, students develop crucial skills such as teamwork, leadership, and adaptability, preparing them to excel in diverse academic and professional settings. Through these initiatives, the institution aims to cultivate well-rounded individuals who are not only academically proficient but also socially conscious and equipped to make meaningful contributions to their society and the nation at large. The institution is privileged and deeply committed to integrating these productive changes for holistic educational development that nurtures the

overall growth of students' academic potentials by exposing them to diverse disciplines and a plethora of ideas for development and exploration.

16.Academic bank of credits (ABC):

The Academic Bank of Credit (ABC) is a virtual repository that stores information on the credits earned by individual students throughout their academic journey. The institution acknowledges the importance of registering for the NEP proposed ABC to foster a learner-centric approach, promote interdisciplinary and provide students with opportunities to enroll in courses of their choice and pursue them at their own pace. The college embraces a flexible learning approach through a choice-based education system, supported by robust technological and infrastructural facilities conducive to implementing the ABC system effectively. With the ABC system, students gain the flexibility to transfer credits and enter/exit educational institutions based on their accumulated credits. The college has invested significant efforts in aligning with the objectives of the ABC system, emphasizing student-centric and learner-friendly approaches in its curriculum design. Currently, NSS, NCC, sports, Scouts, Guides and YRC students can acquire additional credits through extracurricular pursuits such as participation in annual camps, blood donation camps and extension activities organized at University, district, state and national level. This provision expands the holistic educational opportunities available to individuals, reinforcing the institution's commitment to providing a comprehensive and enriching learning environment.

17.Skill development:

Each department offers certificate courses tailored to boost employability and skill development through Value Added Courses. The NEP Curriculum has provided student opportunity to enhance their skills in their degree programme such as Digital fluency, Artificial Intelligence, India & Indian Constitution, Environmental Studies, Financial Education & Awareness, and Cyber Security as a Skill Enhancement Courses (SEC). The Institute seeks collaborative & Memorandum of Understanding (MoU) for skill development initiatives. Students are provided training programs through Placement Cell, Career Counseling Cell and English Lab. In addition expertial learning methods Such as Internship / Industrial Visit / Field Visit & Academic Projects help the Students in skill development. Special days are observed to impart societal values. The college, through BLDE Association's MoU with Deshpande Educational Trust and the National Skill

Development Corporation (NSDC), aims to provide employability skills to graduate from rural and semi[1]urban regions. Training includes employability and interview skills. Several numbers of students are selected in the placement drive organized in the college. These initiatives underscore the college's commitment to holistic education and equipping students with practical skills essential for their professional success and societal contribution.

18.Appropriate integration of Indian Knowledge system (teaching in Indian Language, culture, using online course)

The college has Bhasha Vignana Vedike as a platform for Students to learn about Indian languages & culture. The students also have an opportunity to learn Indian languages such as Kannada, Hindi, Marathi & Sanskrit. In addition cultural events, food festivals & celebration of Jayantees contribute to promote unity & diversity and thus create awareness among the students about the cultural heritage of India. The college has Women Empowerment Cell & ICC through which various activities & programs are organized to create awareness about gender equity, Indian culture, Indian value & entrepreneurship. The college has MoU's with corporate companies which facilitate the students & faculties for online Courses. Thus the college is committed to enable the students to appreciate the Indian culture & values and be instrumental in-creating culturally & ethically a strong society.

19.Focus on Outcome based education (OBE):Focus on Outcome based education (OBE):

Outcome-Based Education (OBE) is a student-centric approach to education that emphasizes clearly defined learning outcomes. It focuses on what students are expected to know and be able to do, leading to improved competency in knowledge acquisition and cognitive skills. OBE encourages students not only to memorize facts but also to analyze and interpret complex information, thereby identifying their strengths and weaknesses. Before each program begins, students are briefed on Program Outcomes (PO), Program Specific Outcomes (PSO), and Course Outcomes (CO). All undergraduate and postgraduate programs at the institution are aligned with Outcome-Based Education, taking into account local, regional, and global requirements. Each program has clearly stated POs, PSOs, and COs, designed in accordance with Bloom's Taxonomy. The adoption of OBE ensures that the curriculum meets both educational and employment sector needs, producing skilled professionals. The college's IQAC ensures faculty and students are well-informed about OBE through regular Faculty Development Programs (FDPs) and awareness sessions. This shift from teacher-

centered to student[1]centered learning empowers students to make informed choices based on their aptitudes and desired outcomes. The institution also updates its official website with details of expected outcomes for each course program, enhancing awareness of this adopted learning approach. Overall, OBE serves as a pedagogical model that enhances the quality of the curriculum and prepares students for success in both academic and professional spheres. The institution's commitment to implementing and promoting OBE reflects its dedication to providing a learner-centric educational experience.

20.Distance education/online education:

The institution prioritizes flexibility in learning and exploration, facilitated through ICT-enabled teaching infrastructure such as Wi-Fi enabled departments, smart classrooms, and well-equipped computer labs. Faculty members underwent intensive training to adapt to the evolving educational landscape, encouraging student engagement in virtual classrooms. The Time Table Committee and the PG Coordinators prepares a common time table for UG courses under the guidance of the Principal and the IQAC coordinator. The master time table serves as a reference for all the HOD's to assign the workload in accordance with the University guidelines. Regular monitoring by the faculty members and HOD's enable the students to actively participate in various college activities.

The CIE is followed by the semester end examination conducted by the Parent University. Such a comprehensive approach ensures a holistic evaluation of students learning and promotes their

overall development.

The rules and regulations for evaluation process are laid down by the affiliating University and are communicated to the students through notices and in the orientation sessions organized by UG, PG and Ph. D. programmes.

As per the Parent University guidelines two Internal Assessment Tests are conducted in the 8th week and 12th week of every semester. The Examination Committee of the college prepares centralize time-table for the UG Arts and Science programmes. The students are informed about the syllabus and the time-table well in advance. The self-financed courses BCA, MA (English), M.Sc. (CS), M.Sc. (chemistry), M.Sc. (Physics) and Ph. D. (Chemistry) individually hold the two internal IA tests as per the Parent University guidelines.

The Answer-Scripts are evaluated by the faculty and the marks[1]lists are displayed on the notice board of the respective departments. The student's signature is taken on the IA marks[1]list. Grievances if any are addressed and are recorded in a register maintained by the respective departments. The final IA marks are entered in the UUCMS portal. The projects of UG and PG programmes are guided by the faculty of the respective departments.

The tentative schedule for the two Internal Assessment (IA) tests is mentioned and the Internal Practical tests for the UG & PG Science and few arts programmes are conducted by the respective departments. IA answer scripts are evaluated and students are informed about their performance. The students' grievance with regard to IA is resolved before the final submission of IA marks at the UUCMS portal and same are recorded in a register and maintained by the respective departments.

The UG Arts and Science disciplines provide institute-labeled answer sheets for IA tests and the self-financed courses provide department Blue-Books.

The collage which is having its glorious history has a well equipped Classrooms, Laboratories, Library and Computer labs to cater the academic needs of the 1726 students of 03 U.G. and 04

P.G. Programs. There is 01 Girls Hostel to accommodate 320 students. There are 30 Classrooms in that 10 class rooms with 10 Projectors (Mounted) in LAN facilities and the entire Campus is Wi-Fi enabled. There is 01 Auditorium Hall and 07 gallery halls in the College with ICT infrastructure. The College has in all 26 well equipped Laboratories under various Science Departments and a English Language Lab. The B.Sc. Computer Science and BCA/M.Sc. Laboratories together have 85 computers connected on LAN & wireless internet connectivity. There are 04 Smart Boards in BCA, Statistics, B.Sc. (CS) and Zoology Departments. The rules and regulations for evaluation process are laid down by the affiliating University and are communicated to the students through notices and in the orientation sessions organized by UG, PG and Ph. D. programmes.

As per the Parent University guidelines two Internal Assessment Tests are conducted in the 8th week and 12th week of every semester. The Examination Committee of the college prepares centralize time-table for the UG Arts and Science programmes. The students are informed about the syllabus and the time-table well in advance. The self-financed courses BCA, MA (English), M.Sc. (CS), M.Sc. (chemistry), M.Sc. (Physics) and Ph. D. (Chemistry) individually hold the two internal IA tests as per the Parent University guidelines.

The Answer-Scripts are evaluated by the faculty and the marks[1]lists are displayed on the notice board of the respective departments. The student's signature is taken on the IA marks[1]list. Grievances if any are addressed and are recorded in a register maintained by the respective departments. The final IA marks are entered in the UUCMS portal. The projects of UG and PG programmes are guided by the faculty of the respective departments.
